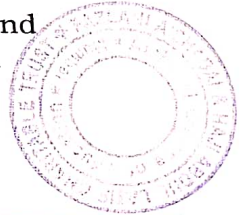

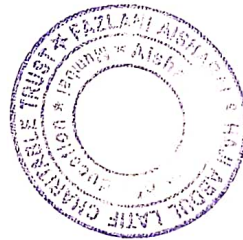
- **Review:** Periodically review and update the code of conduct to reflect changes in institutional policies or external regulations.
