This agreement is made on Friday of 5th July, 2024 between CDOE, JAMIA MILLIA ISLAMIA (hereafter referred as 'CDOE, JMI') having its headquarters at NEW DELHI and AISHABAI COLLEGE OF EDUCATION, having its office at Municipal School Building, Near Gate No- 14, I. J. Hospital Compound, Byculla, Mumbai - 400008

WHEREAS CDOE, JMI agrees to activate a Study Centre for its programmes run through distance mode;

AND WHEREAS AISHABAI COLLEGE OF EDUCATION have expressed their desire to run the programmes approved by CDOE, JMI;

AND WHEREAS the parties have agreed to abide by the terms and conditions as set out hereafter;

Programmes approved by CDOE, JMI for the Study Centre :

1) Diploma In Early Childhood Care and Education (DECCE).

A) Admission

i) Normally a minimum of 100 students is viable for opening a Study Centre. However, at least 40 students in each approved programme is mandatory in order to avail financial assistance from CDOE, JMI.

ii) AISHABAI COLLEGE OF EDUCATION will procure the prospectus and application forms for all prospective candidates in different programmes approved by CDOE, JMI and submit the filled in application forms to CDOE, Jamia Millia Islamia.

iii) CDOE, JMI reserves the right of admissions to the approved programmes in the Study Centre.

B) Study Material

Study Material (SLM) will be provided to all the admitted students in a programme through their respective Study Centre. The Study Centre will send acknowledgment obtained from the students indicating receipt of SLM, to CDOE, JMI.

C) Counselling (Theory, Practical & Assignments)

i) AISHABAI COLLEGE OF EDUCATION will after approval from CDOE, JMI appoint a Study Centre Coordinator who will look after the overall activities (from admission to certification) required for running a programme throughout the academic year at the Study Centre.

CDOE, JMI will pay a monthly honorarium of Rs. 3000/- to the Study Centre Coordinator during activation period.

ii) The Coordinator, Study Centre, will engage counsellors for the various courses/subjects offered in a particular programme as per CDOE, JMI norms and send the list of the counsellors along with their complete CV (specializations, qualifications, contact number, contact address and e-mail details) for the approval of CDOE, JMI.


Counselling sessions in each programme are to be strictly organized in tune with the prescribed syllabi and prescribed counselling schedule in the academic calendar.

CDOE, JMI will pay the approved counsellors so engaged for counselling @Rs.1000/- per theory session of 2 hours duration and Rs. 600/- for a practical session of 3 hours duration. CDOE, Jamia Millia Islamia reserves all the rights to revise the aforesaid rates as and when required.

The cost of the consumables utilised for conducting the practical sessions/examinations (wherever applicable) will be borne by the Study Centre.

iii) In the event of less number of candidates than the stipulated number of 40 candidates, in a particular programme, CDOE, JMI will not extend any financial support towards counsellors/supporting staff etc. for that particular programme for its entire duration.



D) SUPPORTING STAFF

i) CDOE, JMI will reimburse honorarium to the following supporting staff at the Study Centre:

a) Clerk/Computer Operator: one (1) Rs. 1500/- per month.

b) Helper/Attendant : one (1) Rs. 1100/- per month.

c) Safai Karamchari : one (1) Rs. 800/- per month.

The Study Centre will intimate the names of the persons engaged against the above mentioned supporting staff to CDOE, JMI along with their details such as address, contact number and qualification.

E) EVALUATION AND EXAMINATION

i) Internal Assessment:

It will be the responsibility of the Study Centre to collect the assignments from the students/learners; get these assignments evaluated through the counsellors and send the assignment marks awarded to CDOE, JMI as per schedule stipulated in the Academic Calendar.

Similarly, internal assessment marks in respect of practicals, wherever applicable, should be sent to CDOE, JMI strictly observing the schedule mentioned in the Academic Calendar.

ii) Term-End Examination:

Normally, Term-End Examinations will be conducted at Jamia Millia Islamia/respective Study Centre(s). However, CDOE, JMI reserves the right to decide Term-End Examination Centre wherever it deems appropriate.

Remuneration to the invigilators/superintendent of examination/secretarial assistance/water man will be made by CDOE, JMI as per its norms.

F) MONITORING MECHANISM

CDOE, JMI will keep deputing experts/observers to the study centres whenever it deems appropriate and necessary.

G) CLOSURE OF STUDY CENTRE

The Study Centre shall not be closed by the host institution without prior intimation (at least three months in advance) to CDOE, JMI.

- 4.2 Threco will be responsible for the statutory compliances including environmental compliances pertaining to the scrap disposal activities and AISHABAI COLLEGE OF EDUCATION will not in any way be responsible for the same once the scrap material is handed over by AISHABAI COLLEGE OF EDUCATION to Threco.

E- WASTE MANAGEMENT AGREEMENT

This Agreement, entered into on 1st January, 2024 as the "Effective Date" by and between AISHABAI COLLEGE OF EDUCATION having office at (J.J.Hospital compound, Municipal School Building 1st Floor, Gate No. 14, Byculla, Mumbai 400008), here in after called "AISHABAI COLLEGE OF EDUCATION" and Threco Recycling LLP, having its office at D-402 Remi Bizcourt, Shah Industrial Estate, Off Veera Desai Road, Andheri West, Mumbai 400053, here in after called "Threco".

Whereas AISHABAI COLLEGE OF EDUCATION has identified E-waste (E-waste as per E-waste Management Rules, 2022) that it may from time to time wish to recycle, and Threco desires to execute a complete waste management program on behalf of AISHABAI COLLEGE OF EDUCATION to process the E-waste.

THEREFORE, AISHABAI COLLEGE OF EDUCATION shall provide, and Threco shall recycle the Material in accordance with the following terms of this Agreement:

1. Material:

6 Terms:

This agreement shall have a term of Five (5) years from the Effective Date. Threco will be the official/ exclusive E-waste collector and recycler for the institution.

7. Independent Contractor:

In furnishing Services pursuant to this Agreement, either Party will at all times be acting as an independent contractor and this Agreement will not be construed to create any association, partnership, joint venture, relation of principal and agent or employer and employee between one Party and the other Party or its agents.

8. Miscellaneous:

8.1 All services performed by Threco for AISHABAI COLLEGE OF EDUCATION while this Agreement is in effect shall be subject to its provisions unless otherwise agreed in writing before the performance of such services is started.

8.2 This Agreement may be terminated at any time by AISHABAI COLLEGE OF EDUCATION or Threco, upon material breach by either party or upon 30 days written notice to the other party without any reason.

8.3 If any provision of this Agreement is held invalid or unenforceable, then it shall be considered severable (only to the extent necessary) and the remaining provisions will not be impaired and this Agreement will be interpreted as far as possible to give effect to its stated purpose.

8.4 This Agreement will benefit and bind AISHABAI COLLEGE OF EDUCATION, Threco and their respective representatives, successors in interest, and mutually permitted assigns, as appropriate.

8.5 This Agreement constitutes and fully expresses the entire and only agreement between the parties with the respect to the subject matter thereof; all prior and collateral understandings, agreements and promises with respect thereto are considered merged herein. This Agreement may not be modified, waived, or extended unless mutually agreed to in writing, and it may not be terminated except as provided above. A waiver by either party of any terms and conditions of this Agreement in one or more instances will not constitute a permanent waiver of such terms and conditions unless so stated in writing.

8.6 The laws of India will govern the validity, interpretation, construction, performance and enforcement of this agreement. Both the parties mutually agree that the Courts in Mumbai, Maharashtra shall have the sole and exclusive jurisdiction, with regards to the present Agreement and the rights and obligations contained herein, in exclusion of all other courts.

9. Confidentiality

The agreement protects the information provided to Threco by AISHABAI COLLEGE OF EDUCATION from further disclosure or misuse. The information shall not to be disclosed to persons other than Threco's personnel having a reasonable need for access to serve AISHABAI COLLEGE OF EDUCATION. The provisions of this clause shall apply mutatis mutandis to the other party.
